White Time Cards for 'A' Meets	3 packs (150 cards) to teams with 3 home dual meets 2 packs (100 cards) to teams with 2 home dual meets
DQ Slips	1 pack of 250 slips
RTO Slips	4-6 pads of 50 slips per pad
Scratch Slips	10 per team
USA Swimming Mini Rule Books	2 books to each team
NVSL Handbooks	Per order submitted to NVSL, minimum of 15 per team
'A' Meet Ribbons	Bag of 3 sets of 1st-6th to teams with 3 home dual meets Bag of 2 sets of 1st-6th to teams with 2 home dual meets
Labels for 'A' Meets	~45 sheets to teams with 3 home dual meets ~30 sheets to teams with 2 home dual meets

## Notes

- \* **Home team provides all ribbons** at 'A' meets. Usually each team provides their own ribbons at 'B' meets.
- \* **White time cards** are for 'A' meets only. Use yellow cards for 'B' meets.
- \* **Ribbons** are awarded for all legal swims, including **second place relays**.
- \* **Ribbon labels** are 3-column for both A meet and B meet ribbons. If you have old 2-column labels, you can use them up.
- \* **USA Swimming Rule Books** are now available for free in searchable PDF form from <https://bit.ly/3nak7vD>. Extra hard copies of the rule book are available from Swim Outlet [www.swimoutlet.com](http://www.swimoutlet.com) – note that there are two sizes, regular (\$14) and mini (\$7).
- \* **NVSL Handbooks** will be supplied in hard copy in the quantities requested. A minimum of 15 will be provided for your team reps, referees, starters, S&T judges, and scoring table.
- \* **Return unused 'A' meet ribbons** to your DC at Divisionals.
- \* **Other unused supplies** (unopened packages of scratch sheets, DQ slips, and RTO slips) can be returned via your DC if you have accumulated excess.
